MINUTES OF A SPECIAL MEETING BOARD OF DIRECTORS OF THE MADRID COMMUNITY SCHOOL DISTRICT MONDAY, APRIL 26, 2021

Call to Order

The Board of Directors for the Madrid Community School District met for a special meeting open to the public on Monday, April 26, 2021 in the Madrid Jr/Sr High Library. Meeting was called to order by President Lauren Clark at 4:31pm.

Roll Call

Members present Allie Antonovich, Chelcie Badgley, Lauren Clark, and Jessica Smith. Tyler Simmons was absent. Others present were Superintendent Brian Horn and Board Secretary Kris Van Pelt.

Special Meeting Agenda for April 26, 2021

Moved by Antonovich, second by Badgley to approve the special meeting agenda for April 26, 2021 as presented. Roll call: Badgley, Smith, Antonovich, Clark. Motion carried 4-0.

Public Hearing on 2020-21 School Calendar

President Clark opened the floor for public comments on the 2020-21 School Calendar. There were no comments received. President Clark closed the public hearing.

2020-21 School Calendar

Moved by Antonovich, second by Smith to approve updates as presented to the 2020-21 school calendar. Roll call: Smith, Antonovich, Badgley, Clark. Motion carried 4-0.

The updates approved include an early dismissal on Thursday, May 13 at 2:00pm due to hosting district track; students last day as Friday, June 4, 2021 with an 11:00am dismissal; and two (2) additional staff development days, Monday, June 7 and Tuesday, June 8.

Exempt Session – Negotiations Strategy – Iowa Code 20.17 (3)

The board entered into an exempt session for negotiations strategy – Iowa Code 20.17 (3).

2021-22 Collective Bargaining Agreement between the Madrid Education Association & Madrid Community School District and Issue Contracts

Moved by Antonovich, second by Badgley to approve the 2021-22 Collective Bargaining Agreement between the Madrid Education Association and Madrid Community School District and issue contracts.

The settled agreement is an additional \$700 on base, increasing the base wage to \$34,710. Roll call: Antonovich, Badgley, Smith, Clark. Motion carried 4-0.

District Insurance Plans

Moved by Antonovich, second by Smith to approve the Select 750 insurance plan as the base plan for a staff who are eligible to participate, effective July 1, 2021. Roll call: Badgley, Smith, Antonovich, Clark. Motion carried 4-0.

2021-22 Certified Staff Salary Schedule

Moved by Badgley, second by Antonovich to approve the 2021-22 certified salary schedule, as presented. Roll call: Smith, Antonovich, Badgley, Clark. Motion carried 4-0.

2021-22 Administrative and Classified Staff Salaries/Benefits and Issue Contracts/Letters of Assignment

Moved by Badgley, second by Antonovich to approve the settlement salary percentage increase of 3.29% on wages for administration; an increase of 3.29% or a minimum of 50¢ an hour for classified staff, unless frozen; continue insurance offering for those who are eligible, and issue contracts/letters of assignment. Roll call: Antonovich, Badgley, Smith, Clark. Motion carried 4-0.

Starting Wages for Classified Staff

Moved by Antonovich, second by Badgley to approve an increase in starting hourly wages for classified staff, effective July 1, 2021 for the following positions:

Associates from \$12 to \$12.50; Drivers for Activity/Field Trips \$13.40 to \$13.90; Food Service Workers from \$10 to \$11; Food Service Secretary and Kitchen Manager from \$12 to \$13. Roll call: Badgley, Smith, Antonovich, Clark. Motion carried 4-0.

There was no further business to come before the Board for consideration at this time. Moved by Antonovich, second by Badgley to adjourn the meeting. Roll call: Badgley, Smith, Antonovich, Clark. Motion carried 4-0. President Clark adjourned the meeting at 5:33pm.
