American Rescue Plan Act Fund

WHEREAS, March 11, 2021, the American Rescue Plan Act of 2021 was signed into law allocating dollars for State & Local Fiscal Recovery and;

WHEREAS, Boone County anticipates receiving \$5,095,647 to be used only on allowable expenditures as determined by the U.S. Treasury; **THEREFORE, BE IT RESOLVED** that the Board of Supervisors of Boone County hereby authorizes the set up of a dedicated sub-fund of the General Fund for purposes of isolating these funds from the rest of the General Fund.

RESOLUTION FOR ESTABLISHING SPEED LIMIT ON QM AVENUE

Boone County Resolution No. 21-27 **WHEREAS**, the Board of Supervisors is empowered under authority of the Iowa Code of Sections 321.255 and 321.285 of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation, that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS, such an investigation has been requested and had been completed by the Boone County Engineer,

WHEREAS, QM Avenue does not have a speed limit posted,

WHEREAS, the surrounding area has become more urbanized, **NOW THEREFORE, BE IT RE-**

SOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY that the speed limit be established and appropriate signs be erected at the location described as follows: The speed limit be established at 35 miles per hour on QM Avenue from state highway 210 to 322nd lane. Resolution adopted this 25 day of August, 2021.
