Please consult your voter registration notification card or the list above for your current polling location. If you do not have a voter registration card, you can request one by contacting the Auditor's Office. You may only request a card for yourself, not another person. Contact the Auditor's Office with any questions about your voter registration. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered in their current residential precinct, i.e., voters registering to vote on Election Day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence, if required) has the following options:

1) may have the voter's identity/residence attested to by another registered voter in the precinct; 2) prove identity and residence using Election Day Registration documents; or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by 12 noon on Monday, November 8, 2021. Election Day Registrant attestors must provide an approved form of identification. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle.
